Future of Jobs – NBLC's Economic Insight Conference Focuses on Big Changes Ahead for North Bay Jobs



On June 9th, NBLC is presenting a forum on the future of jobs, one of the most compelling concerns for employers in this century. This forum will look at how the way we work is undergoing big changes and what those changes might be for the North Bay. Predictions are that 50% of today's jobs will disappear by 2025 – 2030. What jobs are at risk here? How safe is YOUR job? How is the definition of "job" being updated? What do experts think needs to be done now to prepare the workforce for the new job requirements? How can we educate and train today's students and current workers to have the right skills to be employable? What happens to thousands of displaced workers?

All of these questions and more will be discussed at this conference. Gaining understanding of these massive changes will shape how your organization and your

workforce fare going forward. It is predicted that the newly adopted \$15 minimum wage will accelerate the adoption of automation. Are you ready?

Keynote speaker, Michael Chui is a partner at McKinsey Global Institute (MGI), where he leads research on the impact of information technologies and innovation on business, the economy, and society. Chui is a co-author of the ground-breaking report, <u>Four Fundamentals of Workplace Automation</u>. He says, "Very few occupations will be automated in their entirety in the near or medium term. Rather, certain activities are more likely to be automated, requiring entire business processes to be transformed, and jobs performed by people to be redefined, much like the bank teller's job was redefined with the advent of ATMs." Learn more about how those business processes will be transformed at the conference.

NBLC Endorsements for June Primary

This year's primary is exciting because of the possibility that California has a chance to play a key role in selecting the nominees for President. While usually the late date of our primary doesn't give us that

opportunity, this year we get to weigh in! Your vote will be important in choosing the nominee, but perhaps even more important in choosing who will lead the North Bay's counties. And we have two ballot measures that also will direct the future of the North Bay.

While we recommend the following candidates and support for ballot measures,

what we most recommend is that you exercise your right to vote. There has been some confusion about how those who are not registered Republicans or Democrats may vote. If you wish to vote in the Republican primary, you must be a registered Republican. If you wish to vote in the Democratic primary, you must either be a registered Democrat or request a Democratic ballot. If voters wish to request a ballot to vote Democratic, they should do so as soon as possible. There have been snafus in Marin and Sonoma Counties on the date of the deadline. However, Deena Thompson-Stalder, election manager for the Sonoma County registrar of voters, said the county will send out requested primary ballots until May 31. I believe that is true also in Marin County, but should be verified. In both Marin and Sonoma Counties, the deadline to register to vote or re-register your party affiliation is May 23rd.

Many who want to be "independent" of any party, have mistakenly registered for the American Independent Party. This party is not the same as being "independent." If you wish to be independent, you must register as a "No Party Preference" voter. But doing so, may preclude you from voting in some primaries as outlined above.

Measure AA -- Clean and Healthy Bay: Vote Yes (See previous issue for reasons for support.)
Measure B -- MARIN COMMUNITY COLLEGE DISTRICT BOND MEASURE: Vote Yes

Measure B includes: repairs and upgrades to facilities that are necessary to meet current building codes for earthquakes, fires, and safety; updates to classrooms, labs, and vocational education facilities to support the science, engineering, and technology courses students need to be prepared for four-year college and careers; and facilities needed for support and job training for returning veterans. At the Indian Valley Campus, Measure B will allow COM to continue attracting students by providing the updated facilities necessary to offer specialized technical and career training programs — including for firefighters, paramedics and health care professionals — as well as transfer courses. Measure B is critical to increasing enrollment and allowing the college to reach its full potential.

Moreover, this measure includes important fiscal accountability protections to ensure taxpayers dollars stay right here in our community, can't be taken by the state and can't be spent on administration. NBLC agrees with the College of Marin board that students deserve quality, affordable higher education that prepares them for four-year degrees and future careers.

Be Safe – Be Smart: SMART Trains Require Practicing Safety along Rail Lines



In preparation for beginning service later this year, SMART has started system wide testing along

the initial 43-mile route, from the northern part of Santa Rosa to downtown San Rafael. SMART's testing includes running trains, operating railroad crossing gates at intersections and verifying that our train control and communications systems are accurate and working effectively.

FOR YOUR SAFETY

- Never walk on railroad tracks. SMART operates an active railroad and walking on the tracks is illegal.
- Use designated railroad crossings only. Wait for the bells and flashing lights to stop and for the gate to rise completely before crossing railroad tracks.
- Be prepared to stop at railroad crossings. Slow down, look both ways and listen for warning signals.
- When driving, never stop on the tracks and never race a train.
