# Meet the 2017 Leaders of the North Bay!

The 2017 Leaders will be honored at a luncheon on November 3<sup>th</sup> at the Hyatt Vineyard Creek Hotel, Santa Rosa. The 2017 Honorees are:

United We Stand (Community Building): Susan McQuaid, Marin Court Appointed Special Advocate Paint the Community Green (Environmental Stewardship): Pepperwood Preserve The Light Bulb Went On (Innovative/Entrepreneurial Spirit): Pat Harper, Keysight Technologies Empowering the Latino Community: Teen Services Sonoma From Red Tape to Red Carpet: Kimberly Carroll, Marin Housing Authority Murray Legacy Leadership Award: Gary Giacomini (posthumous) The luncheon's keynote speaker is Maria Hinojosa, an award-winning news anchor and reporter who covers America's untold stories and highlights today's critical issues. As the anchor and Executive Producer of the Peabody Award winning show Latino USA which is distributed by NPR, and anchor and Executive Producer of the PBS show America By The Numbers with Maria *Hinojosa*, she has informed millions about the changing cultural and political landscape in America and abroad.

In April 2010, Hinojosa took a groundbreaking step by creating the Futuro Media Group, an independent nonprofit organization producing multimedia journalism that explores and gives a critical voice to the diversity of the American experience. Futuro Media is committed to telling stories often overlooked by mainstream media.



In nearly 30 years as a journalist, she has worked for CNN, PBS CBS, WNBC, and WGBH. Her previous projects include PBS' Need to Know series and the WGBH/La Plaza talk show Maria Hinojosa: One-on-One. Hinojosa was the first Latina to anchor a FRONTLINE report: aired in October 2011, "Lost in Detention" explored abuse at immigrant detention facilities, garnering attention from Capitol Hill to both the mainstream and Spanish-language media.

Hinojosa has received numerous awards for her work including: four Emmys; the 2012 John Chancellor Award for Excellence in Journalism; Robert F. Kennedy Award for Reporting on the Disadvantaged; the Studs Terkel Community Media Award; the Edward R. Murrow Award from the Overseas Press Club for best documentary for her groundbreaking "Child Brides: Stolen Lives." In addition to her broadcast work, Hinojosa has been a weekly syndicated columnist for King Features/Hearst and is the author of two books: Raising Raul: Adventures Raising Myself and My Son, a motherhood memoir; and Crews: Gang Members Talk with Maria Hinojosa, an in-depth collection of interviews with gang members in New York City.

Hinojosa was born in Mexico City and raised in Chicago, IL. She received her BA from Barnard College. She is currently the Sor Juana Inés de la Cruz Chair of Latin American and Latino Studies at DePaul University in Chicago and a Global Post 'Voces' columnist. She lives with her husband, artist German Perez, and their son and daughter in Harlem.

# Exchange Bank Joins NBLC


Since 1994, the Volunteer Center of Sonoma County has named Exchange Bank the corporate champion in its division for raising the most money for the Human Race. In 2016, it was the first financial institution in Sonoma County to become a "HeartSafe" business, installing Automated External Defibrillators AEDs) at most Exchange Bank locations and training employees in CPR.

# **California Jobs Report Illuminates Bay Area's Importance**

The California Center for Jobs and the Economy/California Round Table Employment Report (<u>link</u>) as of June 30, 2017 show several important trends. Some of the key findings are the importance of the Bay Area in driving job creation and income tax generation.

Bay Area Provided 44% of Net Employment Growth Since Recession

"Containing just under 20% of the state's population, the Bay Area was responsible for 43.8% of the net growth in employment since the pre-recession peaks in 2007. Los Angeles Region provided the next largest share at 22.1%, but spread over 29.2% of the population. Inland Empire is the only other region showing employment gains above their population share."



Bay Area Paid 40% of Personal Income Tax in 2015 Tax Year

"The uneven economic performance across California is also reflected in the relative contributions to state revenues from the different regions. The state budget along with the higher baseline spending commitments made in recent years' budget decisions have become increasingly dependent on Personal Income Tax (PIT) revenues. PIT accounts for 69.3% of all General Fund revenues in the recently enacted budget bill (up from 53.5% in 2007-08), and 50.8% of all General and Special Funds revenues (up from 44.0% in 2007-08). At the same time, the revenues that can be expected in future budget years have become increasingly volatile as an already steeply progressive revenue source has become even more so through the enactment of Propositions 30 and 55 as well the expanding use of credits and other special tax provisions as the economic effects of higher tax incidence have become apparent on specific consumer and employer decisions."

"The most current data released by the Franchise Tax Board is the zip code data for the 2015 tax year (taxes paid in 2016). This data is subject to some revision in the final county tabulations that will eventually be published in the Board's annual reports, due to amended tax filings in this and subsequent years. However, the zip code data is a "first look" that enables comparisons between the different counties and regions, as well as forming the base for the Center's estimates of PIT paid by legislative district."

"The following table shows the distribution of PIT liability by region by tax year beginning in 2000, with the population distribution from 2015 shown as a point of comparison. As indicated, the Bay Area accounted for 40% of total PIT liability in the 2015 tax year while containing only 19.4% of the state's population. Only one other region—Orange County—contributed more PIT than its population share, but

at a considerably lower premium. On a relative basis, the lowest shares came from Central Valley, Inland Empire, and Upstate California, with each accounting for a PIT share at about 1/3 their population share."

The report concludes, "The ability of the Bay Area to continue the jobs growth and revenue base growth of recent years now faces increasing constraints. The ability to hire is challenged by growing barriers to labor mobility due to high housing costs and the state's use of a "road diet" as a regulatory strategy. The continued low performance of the state's schools limits the available skills. These conditions exist elsewhere in the state, but the level of the associated costs in the Bay Area have to date been much higher. The failure of the state to enact reforms to contain these costs should also be considered in light of fiscal needs of the state's current budgetary path."

Two takeaways: northern California's political clout is ebbing as the population grows in Southern California. It appears that in this case, "Follow the money," doesn't provide us with the clout we deserve. Second, as we see a slowdown in job creation in the Bay Area, what does that mean for the state's budget? It means that state's dependence on a volatile revenue source is unsustainable and will trigger budget cuts. What can we do to reform the way the state depends on such a volatile revenue source? That needs to be determined. And quickly, as the recession cycle is looming and the budget cuts are coming.
